SUBJECT: Mobile Homes, House Trailers, Etc., Service To

POLICY:

House trailers or mobile homes as defined in Article 550.2 of the 2017 National Electric Code (hereinafter referred to as mobile homes) which are to be served directly by the cooperative will be served in accordance with the following provisions.

- 1. To be eligible for service under this policy, all mobile homes must be provided with water under pressure and sewage facilities installed to meet state, county, and municipal code qualifications.
- 2. The service entrance through which the mobile home is to receive service shall be mounted on a member's pole or structure adjacent to the mobile home and not in or on the mobile home and shall be in accordance with CFEC drawing MHOH1, MHOH2, MHOH3 or MHUG1, whichever is appropriate. This pole or structure shall be installed, owned, maintained, inspected, and repaired or replaced when necessary solely by the member. Caney Fork Electric Cooperative shall not be responsible for any damages caused by the member's pole. The wiring shall be done to conform with all state requirements and National Electric Code requirements and shall be inspected and approved by a state deputy wiring inspector.
- 3. Any underground service referred to in this policy shall be constructed in accordance with CFEC Policy Bulletin #308.
- 4. For service extensions to a mobile home, a distance of 250 feet (primary and/or secondary facilities) will be provided after the applicant pays to the cooperative a contribution in aid-to-construction of \$1500. For any new line constructed beyond 250 feet, the applicant will pay the cooperative \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities as a contribution in aid-to-construction..
- 5. Service to mobile home parks consisting of at least four (4) mobile homes will be handled in the following manner. The park owner will be responsible for providing the cooperative with a plat of the park to aid in the design of facilities. A charge of \$1,500 per lot may be collected as a contribution in aid-to-construction which includes 250 feet from the primary

line to serve the dwelling. For distances beyond 250 feet, the park owner will be responsible for a contribution in "aid-to-construction" of \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities required for the park. Service arrangements with respect to memberships, deposits, billing, etc. may be handled collectively by the park owner or separately by each tenant.

- 6. Depending on design, the contribution in aidt to construction charges may be adjusted as necessary.
- 7. A mobile home occupied as a family unit served through an existing residence will be considered as multiple dwelling unit and shall be billed under the general power rate.
