SUBJECT: Area Coverage and Line Extension

POLICY:

It is the aim of Caney Fork Electric Cooperative, Inc. (in regard to area coverage) to make electric service available to all qualified applicants located within the service area, as soon as practical, at the lowest cost consistent with sound economy and good management without discrimination and favoritism.

Line extensions referred to in this policy shall mean overhead construction from lines which are existing as of the date of application.

Line extensions to mobile homes will be constructed as provided under Policy Bulletin #305.

All rates mentioned in the following are subject to modification, adjustment, or replacement from time to time by agreement between Caney Fork Electric Cooperative, Inc. and Tennessee Valley Authority, distributor's supplier of power.

Qualified applicants for electric service will be considered under one of the following:

- (A) Residence
- (B) General Power
- (C) Subdivisions and Residential Developments
- (D) Commercial and Industrial
- (E) Temporary Extensions

A contribution in aid to construction shall be required for each line extension.

- (A) Residence (see general provisions paragraph 1)
 1. All single phase extensions to a residence up to 250 feet will be provided after the applicant pays a fee of \$1,500. This charge is to be considered as contribution in aid-in-construction.
 2. Applicants desiring service to a residence at a distance greater than 250 feet from the existing line will pay \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities for the distance beyond 250 feet. This charge is to be considered as contribution in aid to construction.
 3. Additional contribution in aid to construction may be required depending on design.

(B) General Power

1. Applicants desiring service to general power loads such as campers, RV's, barns, pig parlors, grain bins, greenhouses, water systems, signs and the like will be provided up to 250 feet after paying a fee of \$1,500. This charge is to be considered as contribution in aid-to-construction.
2. Applicants desiring service to a general power load at a distance greater than 250 feet will pay \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities for the distance beyond 250 feet. This charge will be considered as a contribution in aid-to-construction.
3. Additional contribution in aid to construction may be required depending on design
4. The minimum monthly bill under this section shall not be less than the standard General Power customer charge. A higher minimum monthly bill may be required because of special circumstances affecting distributor's cost of rendering service.

(C) Subdivisions and Residential Developments

1. Plats or plans for subdivisions which require approval from a municipal or county governing body or a branch thereof and residential housing developments that do not otherwise require approval from a municipal or county governing body or a branch thereof must be submitted prior to requests for service.
2. Primary electric facilities must be installed to serve all lots before any lots will be served.
3. A charge of \$1,500 per lot will be collected as a contribution in aid-to-construction which includes 250 feet from the primary line to serve the Residence. For services to the Residence in excess of 250 feet from the primary line, a charge of \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities for the distance beyond 250 feet will be collected as contribution in aid to construction.
4. A charge of \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities shall be collected as a contribution in aid-to-construction for new single-phase primary extensions to serve a subdivision or residential housing development.
5. Due to the significant additional cost of underground facilities, additional contribution in aid to construction may be required depending on design.

(D) Commercial and Industrial

1. All applications for commercial, industrial, and three-phase residential service shall be reviewed by management and the amount of the contribution in aid-to-construction, minimum bill(s), KWH allowances, term of contract, and amount of deposit shall be determined by management within a reasonable time after the receipt of the application and the applicant notified in writing of the results of the review and the amounts set.

(E) Temporary Extensions

1. Applicants desiring short term line extensions will pay a contribution in aid-to-construction of \$10.00 per foot for overhead facilities and \$15.00 per foot for underground facilities
2. Temporary service used primarily for residential and other building construction shall be classified as commercial use and shall come under the General Power rate schedule. (Refer to Policy Bulletin #303)

GENERAL PROVISIONS:

1. A Residence is considered a structure to be suitable and used for human occupancy for the next thirty years. A residence must be provided with water under pressure, sewage facilities and must meet state and county code requirements and National Electric Code requirements.
2. All payments in aid-to-construction are to be made in advance.
3. Right-of-way clearing will be the responsibility of the applicant and will be cleared in accordance with the cooperative's specifications.
